Foreword

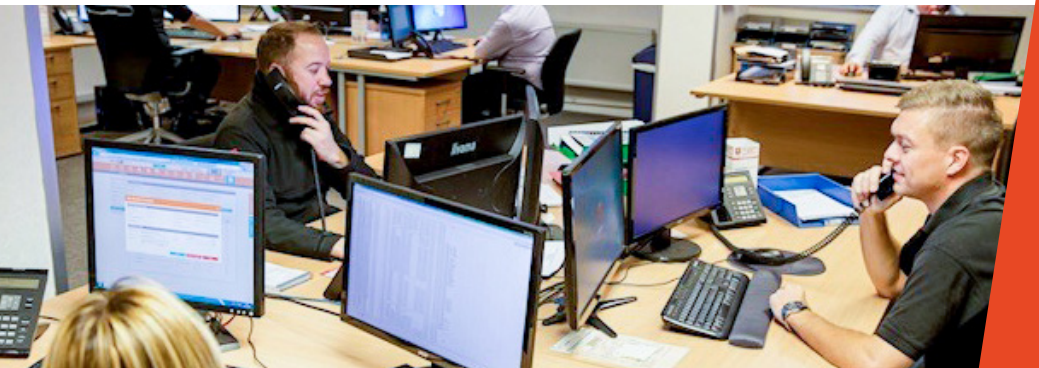

If a desktop PC is used it must have a functional speaker and a microphone. (A headset will work if you have one.) and a web cam



Mobile devices are not recommended due to a small screen size, heavy battery usage and touch screen interaction limitations of the software.

To join the course:

Each candidate will be emailed an invitation and link to join the course. This can get caught by your email security, so please ensure you check all spam and junk folders too. Our Trainer will know you have joined once you have logged in and will show you how to use the system controls before starting the course.

Whilst it may be physically possible for groups of people to view one shared screen, we do not allow this. Each candidate must join as an individual on a separate computer for both identification and certification purposes.

To prevent connection and webcam conflicts we advise you to close other computer applications, such as email and video conferencing applications.

During the course:

You must be present for the entirety of the course, your full attention is required, and interaction expected throughout. There will be interactive question-and-answer sessions for you to participate in.

Training is scheduled for 8 Hours with breaks built in; the trainer will expect you to be visible via your webcam for the duration of the session. The system allows for open conversation between you, the trainer and others on the course. Our software will alert the trainer if a delegate is using other applications on their computer during the course.

For Driver CPC Courses Candidates must be able to provide the appropriate identification as required by the legislation

If you already hold a vocational licence, you will be required to show both your driving licence and your driver qualification card (DQC). You will also be asked to provide your Driver number during the registration process.

If you do not already have a (DQC) you will need to have your driving licence available for us to check your ID and whether you meet the requirements to have DCPC hours uploaded.

The Guide to Maintaining Roadworthiness states that by 2025 there will be an expectation that operators will ensure that all safety inspections include Roller Road Brake Testing or EBPMS.

IRTE Roller Road Brake Testing Qualification is suitable for HGV, Trailer, and PSV Vehicle / Trailer Inspection Technicians.

The training & tests are provided by Prestige Transport Compliance & Training in Partnership with the certificates issued by the Institute of Road Transport Engineers (IRTE)

Course Content

To enable each candidate to pass the Qualification each candidate will need to demonstrate the following.

- ✓ **Understand the dtp number**
- ✓ **The correct vehicle preparation**
- ✓ **Safe and correct use of the Brake Tester**
- ✓ **Understand the report and feedback on the findings of the report**

Course Duration *1-day (up to 4 people)*

- **3-Hour Training Course (Classroom)**
- **1-Hour Online Theory Test (20 questions)**
- **1-Hour Practical Roller Brake Testing (Workshop)**

The qualification will establish that the candidate(s) have the knowledge and competency to undertake a rolling road brake test on heavy goods vehicles, heavy trailers, coaches, and buses, understand the importance of a good brake test result and how that effects road safety and the operators' responsibilities.

Required Equipment

The candidate must have access to a calibrated Roller Road Brake Tester, a rigid vehicle with a GVW of at least 7500Kgs or semi-trailer loaded to at least 65% of the design axle weights. Tractor units can be used for the qualification but must be coupled to a loaded trailer.
